At 6.30 pm, Matthew Kendrick of Grassroots Planning, accompanied by James McCracken, spoke with members regarding plans for developing an area in Bank Road, on the north side of St Peter's School (previously referred to as the 'Mongan site'). It is proposed to build 21 houses, including 4 'starter homes'. All but the starter homes are provided with garages and there are a reasonable number of parking spaces. Members raised a number of questions. It was generally felt that a small estate of this nature would be a great improvement, activities at the site having created nuisance over recent years.

MK was asked whether there might be any benefit for local residents. MK referred to the Community Constructor levy, the modern equivalent of section 106, whereby developers are required to contribute toward local facilities.

With the time around 6.50 pm, the presentation was concluded. The Chairman thanked MK and JM for their attendance.

**The Chairman asked for a minute's silence as a mark of respect for
Miss Doris Friend of Beach Avenue, and
Mr Eric Morse of Redwick Road, both recently deceased.**

Lloyd David Nethercott has submitted his resignation, expressing his utmost regret. His employers have refused to sanction his membership of council, feeling that it would create a clash of interests. Invited to fill the casual vacancy in July, Mr Nethercott signed the Declaration of Acceptance of Office on 14th September. Due to work commitments he had not attended either the September or the October meetings, nor had he surrendered his Register of Member's Interests. Accordingly, he had not officially commenced his term of office as a councillor. South Glos are to be informed and the vacancy will be advertised in the usual way.

Following an invitation to fill the casual vacancy created by the resignation of Mrs Gaulton, Ian David Humphries attended his first meeting. Completing the Declaration of Acceptance of Office and surrendering his signed and completed Register of Member's Interests, Mr Humphries commenced his term of office and on behalf of council the Chairman extended a welcome to him.

3. ACTION/RELATED MATTERS

3 - 1 Grass Cutting

S Glos have recently carried out a comprehensive programme of cuts. The complaints previously registered have been dealt with, apart from that relating to disposal of cuttings. This is unlikely to reach a satisfactory conclusion, S Glos having always stated that they do not dispose of the cut grass. To do so would increase the cost of the service to an unsustainable level.

3 - 2 Ableton Court

The council deplores the course of action taken by the Merlin group, feeling the loss of the elderly persons facility to be without justification. A tree preservation order has been placed on the site by S Glos, probably resulting from the efforts of Alderman Peter Tyzack. FCAB and CEW asked for details of the imminent Merlin meeting as they hope to attend.

3 - 3 Travellers

The visit to S Glos Council was not wholly satisfactory. The travellers' legal representatives have adopted a new policy by applying for a certificate of lawfulness regarding occupation of the Bank Road site. Councillors feel that much of the problem stems from a lack of enforcement over the years – had travellers been moved on when they should have been this situation would not have arisen. It is curious that legislation introduced to protect travellers from persecution should give rise to them receiving benefit and privilege that is not afforded to the settled community. It is also something of an anomaly that if householders do not pay their council tax they will be subject to summons. If travellers do not pay their council tax there is no redress and it does not disqualify them from claiming the site as their permanent abode, even though they may not have lived there for the entire period, nor have ever paid the taxes that settled communities have been subjected to. The public meeting previously referred to was not held - at the request of S Glos. They appear to be optimistic that there is a good case in favour of refusal of the application. This remains to be seen.

6. PUBLIC PARTICIPATION

Jill Fysh, representing the SB Allotment Association, raised a number of questions relating to the operation of the site at Severn Beach. The Clerk confirmed there are difficulties to counter. Occupants of the plots have all paid in advance and all have contracts. The proper notice has to be issued and despite the problems nothing can happen immediately. However, 5 leaseholders have been warned that a 3-month notice to quit will be issued unless action is taken, 10 others have been asked to bring the plots up to standard. A leaseholder has tendered his notice and this plot will be offered for occupancy. Splitting plots into two is also possible and this will be dealt with in due course.

7. AGENDA

7 – 1 Local Major Developments

NAC and the Clerk attended the Site Stakeholder meeting on 24th October. Notes on the meeting have been distributed to members. A bid has been submitted for the takeover of the Oldbury site. The backers, Hitachi, have enough experience to guarantee a seamless takeover.

A complaint has been registered in respect of piling operations in the Western Approach vicinity. These are happening in the evening, as late as 9.00 pm. At present the source/site is unknown.

7 - 2 Village Halls

ILR commented on the possibility of providing further facilities at Pilning. The survey showed that whilst the walls are sound they are not of sufficient strength to support an upper floor without additional work. It was suggested that a building could be erected alongside the hall and the two then linked. To assist in obtaining funding the venture should be designated as a sports hall. Currently there is no wide spread support but as a first step an artists impression is to be produced. Then, with something specific to see, it is hoped that support will be engendered. The fee for this service will be £1,250, Helm Construction being the firm involved. Proposed CEW, seconded FCAB, all agreed, that Helm be asked to go ahead.

7 - 3 Youth Activities/Playground Equipment

Gary Patterson of The Way Gym has asked if timber can be placed on Pilning field with a view to creating an adult activity area. This appears to be a good idea as it would require no cash input and provide a facility for anyone to enjoy.

'Age' signs have now been purchased from Avonmouth Signs. Further advice now indicates that signage should also indicate the need for adults to supervise the use of the equipment at all times.

7 - 4 Timber Yard, Whitehouse Lane

ILR has had further talks with Andy Clarke at S Glos. There has been little activity at the site recently, the owners have instead been active in Avonmouth. Materials stored on the site appear to be at a lower level than previously. The application for a commercial shed on the site has been refused.

7 - 5 In Memoriam

Council agreed the policy suggested under this heading at the October meeting should be adopted. In future council will acknowledge the death of former councillors, or their direct partners, by sending a wreath.

7 - 6 Village Matters

Roads/Road Signs – CEW has contacted S Glos re parking at the corner of Severnwood Gardens/Ableton Lane. The project which led to the parking problem appears to have been completed. S Glos comment merely indicated their inability to act in the circumstances.

Flyposting – CEW drew attention to the response to another matter of concern. All persons posting signs must now obtain permission from council and are required to remove the signs after the event.

Neighbourhood Watch – FCAB reported the next SB group meeting will be held on 14th January. Meanwhile she recommended vigilance following recent break-ins in the village.

Sea Wall – Attention was drawn to an unfortunate event that recently occurred. The wall is a popular place for carers to bring their charges for a walk. One of these persons was seen to bodily lift a local resident and deposit her on the ground, breaking her hip and causing severe trauma. It is felt that carers do not always exercise enough control, possibly feeling they can relax in the open air environment. In this case the carer appeared to be enjoying the company of a colleague rather than paying attention to the whereabouts of the person she should have been looking after.

Advertising – MDP drew attention to a lorry parked along Western Approach. It is covered in notices advising vacancies for HGV drivers. This activity is a contravention of regulations. Streetcare have been advised and one of their officers is to investigate.

Footways – NAC recently became aware of the danger posed by fallen leaves, particularly dangerous in the dark and accumulating in great numbers around the bus shelter at Wick Road. RCG advised that S Glos are about to carry out a clearance programme which should effectively deal with this problem.

Gipsies Plat – ILR has ascertained from Mary Lerner that she is the owner of land immediately adjacent to the path. If Mr Kiely fences his land to the other side it will effectively contain the path within a 6 feet wide channel.

Stride Close – The area is scheduled for clearance.

Allotments – Robin Kirby has again advised his willingness to repair the pavilion roof and clear up the front for £2,000. Meanwhile council consensus continues to be against considering any use of the building.

Burger Bar – S Glos have completed a clear-up around the site.

Clerk of the Council - There was a brief summary of the steps to be taken when the transfer of responsibility between the current and new clerk takes place, including the installation of a dedicated direct line for the council.

7 - 7 Reports

TRAVELLERS – RCG reported on his attendance at the S Glos meeting, also attended by MDP. MDP provided summary sheets for circulation amongst members.

It was felt the meeting achieved little. In general, members of the settled community feel that legislation aimed specifically at travellers gives them advantages that the general public do not have. It also seems to come in a “Love thy neighbour” wrapping. The lifestyles of the 2 groups are so dissimilar that the settled community can find little basis on which to ‘love’ travellers and the gap seems destined to remain.

The Farm Lane site is now cleared. The only way to keep it like that will be to erect bollards that will keep out caravans. At least if the site remains clear there will not be any further intimidation of innocent passers-by.

Many more caravans have pulled into Bank Road. The site was already over-crowded and now poses a health hazard.
