South Gloucestershire Council is now beginning the process of the feasibility study with 3^{rd} party assistance. Clarification given of the 5km boundary for the distribution of the s106 money. South Gloucestershire Council's position is that they are prepared to add a bin under the Localism contract next to the existing red bin at the shop. 8a Public Participation

<u>Severn Beach allotments</u> - An allotment tenant raised concerns regarding security at the allotments now the ground has been cleared. The ground is very boggy to use part of it as an overflow car park.

Details still need to be confirmed but in principle the following will apply.

- Dedicated car parking spaces for allotment tenants
- Consideration to be given to fencing off or creating a bund around the allotments
- Overflow car parking would be at set times and not generally available. It is expected
 the space would be used at summer weekends and bank holidays.
- No overnight parking
- A vehicle height restrictor would be installed.
- Creation of permeable hardstanding.
- Filled in
- Setting up of an allotment committee

ND to discuss the matter further with the allotment tenants

Concern was raised that Beach Road residents were not informed of the alterations to the allotment site.

A question was raised about the compound area, it was confirmed that this would remain fenced off and if containers are used in the future, they will be placed within it.

Plans for the proposed miniature railway were discussed with relation to the allotment site. ND was keen to point out that it could be a fair while before phase three of the project reaches the allotment site.

<u>Teen hut</u> – a resident asked when the Perspex on the teen hit would be removed. Assurances were given that the work will be completed by Christmas 2024.

<u>Mobile homes on Bank Road</u> – a question was asked regarding the matters arising on the November minutes ref 151/100. The Clerk explained that the action was showing as closed because Parish Council are waiting for further information from South Gloucestershire Council who are ultimately responsible for taking enforcement action. Arrangements are being made for a South Gloucestershire Council Enforcement Officer to have a meeting with the Parish Council about all the infringement issues in the area.

<u>Gypsies Platt</u> – A resident who is also a member of the Neighbourhood Plan Steering Group gave a detailed description of how Severn Beach and Pilning have benefited from housing development over the years. With the Neighbourhood Plan coming closer to the parish wide referendum, the resident felt that there is a danger that the single issue of Gypsies Platt may undo all the hard work that the Neighbourhood Plan Steering Group has achieved over the last three years.

Appendix C Unitary Councillor Report

Pilning & Severn Beach Parish Council Report | Monday 2nd December 2024

- South Glos Council is now consulting on the budget for 2025/26, and we're encouraging as
 many people as possible to view all the information online, and feedback accordingly.
 We're facing some real challenges in the years' ahead and hearing from residents before
 decisions are taken is important. We're seeing increasing demand on our Council services,
 and sadly central funding isn't yet keeping pace with these increased demands. You can
 see the latest news item which sets the scene, and links to the consultation online
 Consultation underway on South Gloucestershire budget for 2025/26 and beyond
- Communication continues with Council Officers to determine the now long overdue Certificate of Lawfulness application at Salthouse Farm Park. I've remained in contact with residents to seek a conclusion to this process as soon as possible and ensure their views and feedback is taken into consideration.
- I am in the process of establishing two visits to P&SB. These relate to a planning enforcement visit to better understand the challenges and concerns of local people, and a visit relating to traffic enforcement, aiming to reduce the number of large vehicles abusing the local speed and weight limits through the ward.
- Our wider SGC Local Plan is reaching its final phase of development. The plan is being
 aligned to the updated NPPF which has seen significant changes with the new UK Labour
 Government, requiring additional housing across South Gloucestershire in the years ahead.
 Once a version is available, it will be shared. We are currently awaiting clarification and
 final decisions and timings relating to the NPPF with UK Government. I'm mindful in P&SB
 this will impact work on the Neighbourhood Plan, so I will ensure as much communication
 is available as possible. This also includes locations and policies relating to our traveller
 community which is equally relevant in the villages.
- Council Officers are following up on progress relating to the S.106 funds due for the Panettoni site in Pilning & Severn Beach. Officers will feed back on the timeline for drawing down funding and have not yet started feasibility work for the allocation of the funds which I updated on in the last meeting. I have added the Bristol Wanderers FC (Severn Beach based football club) to the Council email communications should S.106 be available to them to develop facilities in the ward and put them in contact with the Neighbourhood Plan team.
- Parish Councillors and residents will have seen the impact of flooding in the local area during the last 3 weeks. There has been significant disruption and destruction to homes across South Gloucestershire, primarily caused by Storm Bert. The Council provided an overview of the support and situation online this week which can be seen online A review of recent flooding in South Gloucestershire | Newsroom . I passed on positive feedback and thanks to the team at the Lower Severn Internal Drainage Board but would welcome additional feedback on flooding in the P&SB area.
