3 Minutes of the previous Parish Council Meeting

The minutes of the previous Parish Council Meeting held on the 7th October 2024 after amendment to were unanimously approved as a true record.

- 108/671 Christmas tree support Clerk contacted SGC for a print of the buried services data at Redwick Crossroads for the tree support groundworks. Due week commencing 04/11/2024.
- $\underline{142/780-s106\ money}$ On 29/07/2024 SGC were paid the following in relation to the Panitonni site: £15,000 towards sports feasibility study and £146,316.92 towards sports facilities. South Gloucestershire Council is now beginning the process of the feasibility study with 3^{rd} party assistance. Clarification given of the 5km boundary for the distribution of the s106 money.
- <u>144/854 Broad Gauge rail display</u> PT has been able to source more sleepers and cross braces, currently the display is available to view at Crossings House. The Clerk has composed some wording for the interpretation sign. Display hoped to be installed in time for 23rd November, the 60th anniversary of the end of passenger services on the line.
- <u>145/881 Pilning Playing Field flail</u> left hand side will be cut back week commencing 30/09/2024. Too wet currently to carry this out. Still too wet 18/10/2024. Clerk contacted again 28/10/2024. Grass levelling near the site of the old cricket club pavilion to be done at the same time.

8a Public Participation

Pilning station – update to come from Simon Johnson – see below

<u>Free items for collection</u> – residents have been putting out items for free on their doorsteps, unfortunately many items, particularly bikes, are being scattered around Severn Beach Playing Field. Item to go in the next edition of In View.

<u>Trees from South Gloucestershire Council</u> – a resident asked if some of the new trees being proposed could be planted at Severn Beach Playing Field to complete the line of trees along the front boundary. A solution needs to be found to meet the needs of the parish and South Gloucestershire. The person in charge of creating the miniature railway has some suggestions for tree planting that may be acceptable.

<u>Teen shelter</u> – PT had looked at the Teen Hut and treated it with solvent to get rid of the worst of the graffiti. Suggestion was made that the Perspex panels are taken out and the painting scheme mentioned in June be implemented.

<u>Centre of Pilning</u> – a resident complained that the centre of Pilning was looking "a mess" with graffiti on the telephone exchange building, "Village Spice" still looking unkempt, although better than it did.

<u>Pebble display</u> – an update was requested about the pebbles that were painted for the late Queen's Platinum Jubilee. These are in safe storage. The Clerk explained that the display was planned to go on the old bus shelter site next to the memorial tree on Beach Road. Suggestion that a render coat of concrete on the retaining wall behind the Tea cottage into which the pebbles could be set was seen as a good idea

<u>Bristol Wanderers</u> – The team's leader spoke to the meeting expressing a wish to get the Parish Council's support. Mention was made about the possibility of a team using Pilning Playing Field, there are additional challenges at Pilning as there are no changing facilities at the hall anymore. ND noted that the Parish Council does aspire in its Action Plan to support sporting ventures. A grant application had already been received from Bristol Wanderers by the Parish Council but regrettably it did not meet the criteria required for consideration. VB to check with Pilning Village Hall Committee about availability of a meeting room for changing.

Appendix C NPSG Report

Neighbourhood Plan Steering Group (NPSG) Report to Parish Council 4th November 2024 – delivered by Richard Edwards

Since last PC meeting the NPSG has had one meeting on 15th October. Matters discussed and arising since, are as follows:

Flooding

At a WECA ADEPT meeting for SG Severnside on 14th October, Colin Taylor of the EA tabled draft maps for the ASEA re-modelled flood data, covering; current, 2123, and multiple breach scenario. At the end of the meeting these maps were given to Nick Davies for information for the Steering Group. Nick was advised, the data was not expected to be further amended and would be available electronically in a matter of a few days.

Interpretating the maps, there appears to be no tidal flooding predicted for Pilning and only up to around 0.5m for the worst affected areas of Severn Beach. We therefore believe we will be able to make an acceptable flood risk case for new housing development in both Pilning and Severn Beach in alignment with the parameters set out in our Design Codes and Guidelines report. The Sequential Test is being reworked but, will need the electronic data from the EA to finalise it. A hard drive was delivered to the EA on 22nd October to obtain the data, but unfortunately almost 2 weeks later we are still waiting for it to be returned.

Once the Sequential Test is complete, the Steering Group will engage with a consultant to prepare separate generic Exception Tests for the potential site areas for Pilning and Severn Beach. We have briefed SGC Strategic Planning and have some provisional dates reserved for a combined meeting with SGC and the EA.

Neighbourhood Development Plan

We have a sub-group meeting next week to bring the content of the NDP towards readiness for its Regulation 14 consultation.

Evaluation of Sites

We have a meeting next week with Network Rail and SGC to discuss feasibilities for alternative platform location should the need for a 3 trains per hour service be implemented.

There has been no further correspondence from SGC on how they could support potential parking solutions for visitor parking.

The Steering Group attended a meeting with the SB Village Hall Trust where the owner/developer of land at Gypsy Platt presented potential opportunities for the hall and field in consideration of enabling an access road to the site.

The development, over and above the granted planning permission for a single gypsy pitch on the corner of Northwick Road and Bank Road, is challenging the NP's objective of development of the centre of the village for housing or extra care accommodation. We understand the PC has received a letter from a landowner expressing their concerns. Could the PC comment on any enforcement actions being taken by SGC?

Planning Applications

It is noted that there has been a request for a screening opinion for a proposed erection of a wind turbine on land south of Severn Road close to Severnwood Gardens. Although the SG has not met since the application to discuss, it is evident that the screening opinion application maybe somewhat misleading describing the site as an industrial location in Avonmouth.

There have been no other new planning applications of relevance to the NP.

Appendix D Unitary Councillor Report

Pilning & Severn Beach Parish Council Report | Monday 4th November 2024

Key updates for Parish Council colleagues in November 2024;

- Following the last Parish meeting discussion, I met with Ian Davey at South Glos Council to ascertain the S.106 funding due to be awarded in Pilning & Severn Beach. This update has been shared with Parish Councillors, articulating the process by which the funds will be awarded.
- I joined Cllr Mike Pruett visiting the Bristol Wanderers Football Club who play in Severn Beach. The Club have superb aspirations for the future and primarily engage local people in their football club. The Club are looking to raise awareness of their work and fundraise to create more fit for purpose facilities in the ward.
- As a follow up to the last Parish Meeting, I met with Aaron Bush (Planning Enforcement), regarding the planning team processes to enforce action on Bank Rd, as well as Pilning Station. Officers have shared their 2023 Report to highlight the process for allocating traveller sites in the Council.
- An update on the M49 Junction has been shared with the Parish Council following an update from Kelvin Packer at South Glos Council. The updated timeline includes a start date of Spring 2025, and completion in Spring 2026. A further update received this week includes positive news that water vole displacement work has successfully completed, and wider pre-commencement planning conditions have now been discharged.
- In my wider role for South Glos Council, I have attended the Children's Outcome Board this week, will attend the Circadian Leisure Trust AGM & Board, and Chair the Corporate Parenting Board throughout a busy period for the Council. With the UK Gov budget last week, we are in the process of budgeting for 2025/26, looking at all our resource planning aligned to the Council Plan. With an ever-increasing demand on services and strained public finances, there are difficult decisions to make in the months ahead. In the last few weeks I have also attended Full Council meetings, joined the South West Lead Members forum for Councillors across the region leading on Children & Young People, attended a SGC Cabinet Away Day with Cabinet colleagues.
- As requested by local people commenting at the last Parish meeting, I have added my
 comments to planning applications impacting local people such as the proposed truck stop,
 and where required will continue to 'call in' applications to committee.
- I have remained in contact this month with residents at Salthouse Farm Park. The Certificate of Lawfulness is still undetermined and I am chasing Officers to understand why there has been such a delay in the process.
