#### 4 Matters arising

<u>St Peter's School Grant</u> – applicant contacted and encouraged further applications in the future. <u>Four Town Transport</u> – the charity was delighted to receive their grant and thanked the Parish Council for their consideration.

<u>School prizes</u> – both the junior schools were pleased that the Parish Council were still giving a prize, even though it no longer had a monetary value.

<u>SIM card</u> - work in progress for the Cemetery Clerk's work mobile.

<u>Fly tipping camera</u> – the Clerk has not seen any reports that a usual fly tipping hot spot has been targeted recently. This is hopefully down to South Gloucestershire Council's mobile fly tipping cameras that have been deployed.

<u>Pilning Tennis Court</u> – four potential contractors have been identified and invited to submit quotes for the refurbishment of the tennis court. Two contractors so far have submitted schemes for consideration. The information will inform the Council about the grants that might be available.

<u>Freedom of the Parish awards</u> – These appear to have been well received and residents appreciated that the nominees were recognised.

<u>Lack of enforcement action</u> – Clerk to write to South Gloucestershire Council regarding the lack of enforcement action over a case in Pilning.

#### **8a Public Participation**

<u>Pilning station</u> – Residents wanted to know of any actions being taken around Pilning Station. It was reported that a Community Protection Notice (CPN) has been served on the land around Pilning station. Therefore, anyone witnessing a fire in or around the site should contact the police, noting that there is a CPN in place. The Environment Agency are beginning to realise the extent of the tipping at Pilning station. Rubbish has been tipped over the side of the embankment therefore the extent is not obvious from the car park. Aerial images have been supplied showing the development of the tipping site. Rubbish and pollution are getting into the Pill rhine and the Lower Severn Drainage Board are now being included in the multi-agency approach to the issue.

<u>Basketball hoop</u> – The equipment is in the parish and the Clerk is pushing the issue of getting it fitted at the Severn Beach MUGA.

#### .5 Pilning Playing Field

Some of the trees near the tennis court appear to be strangled by their plastic guards. PT noted that the guards are biodegradable and will not cause any harm to the young tree.

Teen hut continues to cause concern. The plan to add gravel under the hut was not met kindly by those who need to cut the grass around it.

#### .6 Severn Beach Allotments

Summer is nearly over and most of the produce has been picked just leaving the winter veg. Time to start preparing for next year.

Plots not being worked are:-

Plot 6, Plot 14, Plot 18, Plot 22, Plot 29

Plot 6 has an apple tree that is now growing far too large.

Plot 18 is so unruly that the paths are now being blocked.

Some work needs to be done on the water butts as the insulation on the water pipes has either been eaten or taken by birds. This will leave the pipe susceptible to freezing. A couple have a bit of subsidence, so water constantly spills over the top, tweaking of the ballcock is needed.

The wood pile is ever growing.

#### .7 Pilning Allotments

Most of the allotments are well tended. One plot has a new tenant.

#### .8 To receive a report from the Cemetery Clerk

The cemetery noticeboard has a grave plan dated November 2021. Should this be updated?

The grass has been cut and graves trimmed. Several toppled head stones and dilapidated graves have been tidied up which is a great improvement.

A headstone audit was carried out and several gravestones were found to be unstable and therefore were laid flat. Del is endeavouring to get in contact with the grave owners, where possible. Work will need to be scheduled as soon as possible to tidy the graves involved.

The new cemetery is looking untidy. The regulations for a grass cemetery are not being adhered to.

Grave boundaries are being stretched to double size, artifacts crowded in and dead flowers are not being removed.

The seat in the old cemetery still needs attention and Del is aware of this.

Northwick Cemetery neat and tidy, there is one toppled grave, efforts need to be made to tidy that up.

#### **Appendix C NPSG Report**

Since last PC meeting the NPSG has held two meetings on 16th July and 20th August. Matters discussed and arising since, are as follows:

#### Flooding

Our frustrations with the availability from the EA of the re-modelled 100-year flood risk data have continued. Since this was expected at the end of February, we've seen a recurring cycle of the model being run by the consultants, the EA receiving and checking the output, only to find errors in the results and requesting the model to be run again with changes needed to the input data.

The last up-date from the EA on 20th August read 'We received the updated (and hopefully final) defended scenario set of model files on Friday last week. We have downloaded them along with the updated report and started our review to ensure all issues have now been addressed. This is scheduled to take until the end of next week. Within this we have also received a test run of the breach scenario and will be reviewing this too. So, it depends on the outcome of our review as to when we can provide you with the results of the defended scenarios, but the soonest would be week/c 2/9'.

#### **Neighbourhood Development Plan**

In the meantime, we've been making some good progress in moving the document forward where we can. One particular topic of interest is how we will re-define settlement boundaries in the document and what can and should be included.

#### **Severn Beach Railway Station**

We have sent a response to NWR (copied to SGC) to their three train per hour service solution report. We've emphasised the potential benefits of moving the double platform a short distance to the south.

#### **Evaluation of Sites**

For potential parking at New Passage and Shaft Road, Ward Councillor Simon Johnson wrote to Emma Blackham, SGC, to formally request SGC to consider these in their plan of work. No response to-date has been received by Simon.

For the potential use of land at SB Primary School to provide an access route to land behind, attempts by us to set up a meeting with the developer, Castle School Education Trust and SGC proved impossible. Instead, it was agreed to do this by a round robin of emails. The NPSG provided the background, and inputs were then made by the developer and CSET, we await an input from SGC. We continue to try to make the village hall trust aware of and consider potential benefits for them and the community in such proposals. Challenged by a councillor at this meeting why the NPSG was supporting this site, it was explained that we are following a process to evaluate all sites put forward as available. This site was put forward in both the SGC and NPSG calls for sites. Evaluation of suitability will continue.

#### **Planning Applications**

There have been no new planning applications of relevance to the NP although some significant decisions have been made.

Construction of a roadside services facility next to the M49 junction has been approved, despite the NPSG and the PC raising objections on lack of HGV provision. SGC's Planning Policy Team also identified HGV as a concern. It is noted in the approval report that SGC's Highways Department is stated as having a 'project in hand' to bring forward a proposal for HGV parking in the Severnside area. Councillors were asked whether they had any knowledge or information on this project. None did, so the Steering Group will make its own enquiries.

Proposals for new dwellings or property extensions in Green Belt and flood zones continue to be refused on those grounds. However, new traveller pitches, such as the ones recently on Marsh Common Road are approved. The planning process would appear to have double standards and be broken in this regard.

#### **Financial Report**

Our grant application with Locality has been processed and £6k funds have been received.

#### **Almondsbury NP**

We have been advising Almondsbury PC of our NP experiences, by attending a meeting and sharing information, as they start out on their NP.

#### **Appendix D Unitary Councillor Report**

#### Pilning & Severn Beach Parish Council Report | Monday 2<sup>nd</sup> September 2024

Key updates for Parish Council colleagues in September 2024;

- With the General Election concluded, Claire Young was elected as Member of Parliament for Thornbury & Yate. This led to changes within South Gloucestershire Council, where Claire stood down as Leader. Maggie Tyrrell was elected Leader of SGC for the Liberal Democrat group and I have taken on the cabinet role and portfolio as member for Children & Young People within the Local Authority. During October, Claire's office will be holding the first of many MP clinics for local people to meet in person and discuss local issues, with the first session expected to be held on Friday 4<sup>th</sup> October (this will be finalised and communicated in due course).
- Claire Young MP will be sharing an update next week relating to her work to secure additional funding for the sea defences within the ward. This additional funding is being sought to ensure the trainline into Severn Beach is protected.
- Following feedback, I have been in liaison with SGC Officers this week, with a view to extending the WECA e-scooter trail into the ward, with a view to enabling people to commute from Severn Beach station into the Severnside distribution area for work. Initial plans for the trial have excluded the station but I have expressed our disappointment at this decision and am pushing for a change in this position as we look to support more people to commute in an environmentally friendly way and reduce traffic locally.
- Residents have expressed dissatisfaction with the recent road closure and resurfacing scheme on the A403 and how the scheme was managed and communicated by the Council. Cllr Sean Rhodes (Cabinet Member for Places) joined Shaun Wilson (SGC Officer), the Parish Council and I on site during the works to review the work to date and make improvements which we hoped to alleviate some of the impact for local people. There was a clear commitment from SGC to communicate better and work with local Parish and Town Council's to ensure schemes are as well delivered as possible, causing as little disruption as possible. Sean and I spent some time after our meeting on site knocking on doors and talking to local residents. Further planned work in September is being communicated ahead of time, seeking feedback on the scheme by the Suez roundabout.
- I have remained in contact with residents at Salthouse Farm Park in Severn Beach, and the Certificate of Lawfulness application by the owner of the site has still not been determined. I'll continue to liaise with SGC Officers to seek an outcome as soon as possible.
- There are a number of planning enforcement issues that remain ongoing within the ward and I
  have requested that the Head of Planning Enforcement provide an update for the Parish
  Council and myself at the earliest opportunity. These relate primarily to Pilning Station and
  Orchard Pools, but in recent weeks extend to planning complaints received relating to land at
  Northwick Road.
