PRESENTATION WITH BRISTOL ZOO PROJECT

Area of interest

The area of interest Bristol Zoo Project are involved mainly concentrates inside the triangle of motorways that surround the Parish. The exceptions being Aust and Hallen Marsh Nature reserves.

Surveys

Surveying work is being undertaken on different aspects of natural habitat in the Parish. Alongside this several SNCI designations (Sites of Nature Conservation Interest) are now out of date and need refreshing as they haven't been surveyed for a long time. Every bit of land that has some biodiversity value needs to be recognised as that so that BZP can protect against it being built on.

The Pill Rhine

The Pill is one of the only real river catchment systems that there is in the project area. It is heavily interconnected; it has a lot of potential. It suffers a lot from water pollution and the quality is not that good but there are issues that can be solved. BZP are going to be doing some work into surveying it for the potential of releasing native white crayfish.

Invasive species

American mink is an invasive species in the area, back in the 1970s very well-meaning people decide to release them from fur farms to freedom and now they're present in pretty much every water way in England. They make voracious predators on other native animals such as water vole as well as seabird populations.

Get involved

Local communities are invited to get involved with the River Detectives project, which is alongside the Bristol & Avon Rivers Trust. The community effort will be to monitor the water quality in the Pill.

Aust Nature Reserve, there is a group that meet every Wednesday, currently mainly a survey group but also discussing the future of the reserve. It's good for nature and as a community resource. Becoming part of the community will ensure it's going to be successful in the long run.

8a Public Participation

Allotment curtilage - A complaint was received from a member of the public at the meeting regarding remaining piles of wood and earth at Severn Beach allotment. Also, that the new car park surface is getting rutted after a very short period.

Allotment car park – A question was asked regarding how the car park at Severn Beach allotments will be managed. ND reported that a permanent height restrictor will be installed, the gate will be closed when the car park area is not in use. It is expected that the operator of the miniature railway will be supervising the gate. Since the meeting in February when it was put forward that the car park would be opened occasionally, it now appears that the car park will be open 10am to 6pm. There is some confusion that needs to be clarified. Concern was raised that decisions were being made with residents not being kept properly informed.

Allotment fencing – An allotment tenant put forward the idea that fencing should be erected around the allotment to prevent unauthorised access, particularly small children potentially hurting themselves.

Beach Road – A suggestion was put forward that Beach Road should be made a one-way street. Item for a future agenda

159/391 Action JE

.2 To receive a report on progress with Severn Beach Miniature Railway

The Clerk had circulated the report prior to the meeting, which PT quoted from.

Two members of the public spoke to support the miniature railway and how it would be a community resource, to be appreciated by local businesses, youth organisations, schools as well as the visiting public to Severn Beach. Local people have already benefited by coming together as a group to support its construction. Mention was made of a young man with additional needs who has really flourished because of the project.

SR raised the issue of planning consent, that care needs to be taken that the project is not going to create problems for itself. Complaints from members of the public who have not felt consulted sufficiently have sadly dampened the project.

It is understood that the scheme comes under permitted development and everything being done has been in good faith with South Gloucestershire Council's knowledge. ND is in regular contact with SGC Enforcement and other departments over the miniature railway.

.3 To decide on submitting a planning application for the "Men's shed" facility

ND explained this scheme does need planning permission, even though there was a building on the site previously. Note plans will permit the Lower Severn Internal Draining Board better access to the watercourses around the allotment site.

.4 To receive a report on the refurbishment of Severn Beach allotment curtilage

ND gave a verbal report on the refurbishment of Severn Beach allotment curtilage.

Current situation is that 1600 square metre of refurbished car park. The access road needs widening slightly and tidying up. It could just be scraped off, but it would be better being made slightly wider for vehicles going in and out.

To widen the access would take an estimated £2000 worth of aggregate. The Clerk was asked if there was sufficient in the 2024/25 budget or whether to wait a few weeks to the next financial year. See 9.5 below.

P25/00232/RVC Former Avlon Works Severn Road Hallen

Response Pilning & Severn Beach Parish Council continues to object to this planning application in its current iteration (being based on P21/06880/F of January 2023) arguing that the outline consent should not have been granted because the development increases the risk of flooding. The 2012 Strategic Flood Risk Assessment and later modelling commissioned by South Gloucestershire Council identified that land raising at the site would increase flood extents and depths. Despite this, the officer's report to the committee did not mention the study or its findings and recommended approval of the development, which the Parish Council believes is contrary to national planning policy.

The Parish Council requests that South Gloucestershire Council either modify the previous consent to eliminate the increased flood risk or revoke the previous consent on the basis that the increased flood risk was concealed from the planning committee.

Additionally, the Parish Council argues that the development is unlikely to employ anyone from South Gloucestershire due to a lack of public transport links and that the site's design discourages the switch to low or zero carbon fuels. The traffic plan also needlessly increases emissions and the site lacks welfare facilities for drivers. The Parish Council welcomes the external seating area, landscaping, and disabled parking spaces but is concerned about the lack of a drop-off area for staff and visitors who require transportation assistance.

The Parish Council requests that the application be refused, and the previous hybrid consent be modified.

P25/00329/RM Land North of Severn Road Severn Beach South Gloucestershire. Reserved Matters Application pursuant to condition 1 of planning permission ref. SG4244 (dated 27th November 1957) for access, scale, appearance, landscaping and Layout, the erection of 5 no. commercial buildings with associated works.

Response Pilning & Severn Beach Parish Council objects to this planning application. This section of land under consideration was taken out of the 1957 consent in 1995 to become a community forest and wildlife conservation.

P25/00342/F Land North of Severn Road Severn Beach South Gloucestershire Land raising enabling works to create plateau (retrospective).

Response Pilning & Severn Beach Parish Council objects to this planning application. Land raising will put the risk of fresh water flooding higher than currently. There is evidence that fluvial flood modelling for future years shows a higher risk.

Note PT also noted that he has witnessed a high tide where the water level of the Severn is above roof ridge of bungalow properties behind the sea wall.

P25/00343/F Land South of Severn Road Severnside Avonmouth [sic] Creation of plateau and relocation of pond (retrospective).

Response Pilning & Severn Beach Parish Council objects to this planning application. The land raising has taken place it caused the loss of a mature oak tree that had a preservation order and significant detriment to wildlife. As with P25/00329/RM this land was taken out of the 1957 consent in 1995 and as part of the Masterplan with the aim to become a community forest and wildlife conservation area. If this planning application is granted, then the wider implications of the 1957 consent changed in 1995 could potentially mean development right out into the Severn Estuary.

Now that this application is live it was resolved for the Chairman and Clerk to write to Claire Young MP to call the application for parliamentary scrutiny.

Appendix C NPSG Report

Neighbourhood Plan Steering Group (NPSG) Report to Parish Council 3rd March 2025 – delivered by Richard Edwards

Since the last PC meeting the NPSG met on 18th February.

Matters discussed at the Steering Group meeting and arising since are as follows:

Flooding

The specification for a consultant to produce a level 2 Strategic Flood Risk Assessment was agreed with both the EA and SGC. This was sent out to tender to three consultants who all returned proposals. After one round of clarifications, we appointed JBA consulting for the work on 19th February. The important work should be delivered within the scope of our available grant budget. JBA have a strong reputation and know our area. They have completed SFRA work before for SGC including Oldbury-on-Severn's NP. JBA commenced work immediately and we held an inaugural meeting on 24th February. The expectation is that the report will be finished in 8 to 10 weeks.

Planning

P24/02984/CLP - Land raising works (either side of Farm Lane), necessary to facilitate warehouse development – the Steering Group has posted its objections.

We'd like to thank our Ward Councillor for arranging a meeting with SGC planning enforcement. This will take place later this month and the Steering Group is now preparing for that.

Progress

With the excellent news on the Flood Risk work, we are now able to see light at the end of the tunnel for the NP. Particularly for the benefit of new councillors and the residents present, it's worth re-capping what the home run will be and the benefits of the plan.

- Strategic Environmental Assessment and Habitats Regulation Assessment of potential sites
- Finish site evaluations
- Complete the Neighbourhood Development Plan
- Regulation 14 Consultation to the public and statutory bodies
- Submission of the plan to SGC by the Parish Council for its Inspection – essentially legal compliance
- Public referendum

Benefits

- To give the Parish its say, which must be considered during future planning applications
- To protect what we have, but to enable some new housing, car parking, retail, etc.
- Allowing young people and their families and older people who may need a little care to live/stay in the Parish
- Sustainability of the community, keeping schools and businesses open, improving facilities
- Funding – an agreed NP raises CIL income from 15% to 25% allowing the parish to invest in community, leisure and sporting facilities
- Aspirations – a list of non-planning related projects that could be taken on by the Parish.

Appendix D Unitary Councillor Report

Pilning & Severn Beach Parish Council Report | Monday 3rd March 2025

Key updates for Parish Council colleagues in March 2025;

- Several people joined the Community Engagement Forum (CEF) last week online to hear updates on local matters. This included a very positive update from South Glos Council in relation to the M49 junction. The final two legal contracts have now been signed, meaning all land ownership is in place to proceed with the junction build this spring. Once underway, there is a 12 month build programme which is being done within South Glos Council. Officers are aiming for late May at the latest.
- I spent some time in Severn Beach on Saturday and was joined by Claire Young MP and Leader of SGC Maggie Tyrell. We spent time knocking on doors, talking to local people and answering questions about any of the work of the council, and where Claire can support in her role as MP. Some of the key themes included parking challenges at weekends with visitors, the need for the dog warden to visit more regularly and feedback on proposed changes to black bin collections. I also spent some time with residents in Pilning discussing the challenges they are facing with speeding traffic and weight limits being ignored which I'm following up with Cllr Rhodes who attended a recent meeting.
- A meeting with South Glos Planning Enforcement has been established for Tuesday 18th March. This follows Parish Council concern that there are several planning matters not being seen to be properly enforced in the ward, so this meeting will be a chance to visit sites and discuss in person to reach a resolution with Parish Councillors and Neighbourhood Plan colleagues.
- Conversations with colleagues relating to Pilning Station are ongoing. I received an update on the multi-agency meeting in September 2024 which was attended by SGC, National Rail, Planning Enforcement, Police and Environmental protection. I would welcome Parish Council thought of establishing a smaller, more agile working group of key people associated with the site and develop a plan outside of the full Parish meeting as there are no currently planned multi agency meetings scheduled and no recent reports. I'm aware of a parallel piece of work being led by Claire Young MP to engage in the project.
- Every effort continues to be made in relation to the 918 bus that is vital for young people in the ward. We are awaiting the final lists from WECA, and colleagues remain in contact with parents group representatives.
- WECA are going to reply to my query regarding e-scooters trial expansion. This is due to be received by April as we look to improve the connectivity from Severn Beach station to Severnside.
