#### **9 AGENDA ITEMS**

# .1 To decide on whether land by Gypsy Platt may be included in the NP for potential development

Following concerns raised previously, regarding land at Gypsies Plat, clarification was sought about the progress of the Neighbourhood Plan regarding land at Gypsy Platt. Concern was raised that the plan would be seeking to develop the land. This is very far from the case. Strict processes apply to all potential development sites that have been forwarded by landowners, whose objectives include identifying how the Parish can meet its future housing and development needs. It is not the NPSG's role to approve or otherwise but to show that such sites are potentially available for future consideration. It was clarified that all proposed developments would still have to follow existing rigorous planning application procedures which include the opportunity for everyone to support or object.

PT requested an agenda item for a future meeting "To decide on Gypsy Platt land to be assessed for designation as a Local Green Space."

#### .2 To decide whether to take a lease of Promenade Gardens

After discussion regarding the project benefits and possible costs that could be incurred, the council looked favourably at the motion.

Vote SKG proposed and JO seconded agreed unanimously

# .3 To decide whether to grant a sublease of Promenade Gardens

Completely dependent on the successful outcome of 9.2 of this agenda the Parish Council would consider subleasing land to Mr Joe Nemeth for the purposes of a miniature railway.

The proposed length would be from the boundary of the Tea Cottage following the permitter of Promenade Gardens as far as the gate by Severn Beach allotments. The width of the land needed will be approximately four metres.

The proposal from Mr Nemeth is for the line to be built in three stages, see the schematic map below. Note there are two options in the phase 3 allotment area, option a) is the line running to the first curve and the engine shed being erected there, option b) the line running to the site of the former rugby club where there are utilities already available.



Also, it was agreed that Mr Nemeth would be responsible for the opening and closing of the access gate beside the Tea Cottage to form a car park next to the proposed station. This will also be subject to South Gloucestershire Council consent regarding the creation of a car park. Mr Nemeth will be responsible for public liability insurance and the safe operation of the railway. The equipment will also be insured by Mr Nemeth when the line is not in use Having heard the proposals, the motion was put.

# .4 To decide whether to clear the overgrown area of SB allotments and make available for use.

One quote has been secured for the clearing of wasteland at Severn Beach allotments with a view to firstly tidy the area, secondly to possibly create a temporary overflow car park and lastly to reuse the existing concrete pad as a potential location for a Men's Shed Association club house.

PT proposed and SKG seconded agreed unanimously Resolved for the Clerk to seek other quotes

# .5 To decide on starting negotiations to close a right of way at Pilning Playing Field.

A resident spoke about access onto Pilning Playing Field from Bank Road through the former railway gate at the top left-hand side of the field. The resident would like to buy out the Right of Way. The Chair explained that the Parish Council is currently seeking tenders for grass cutting contracts and that contractors may well be looking to use that gate, as they do currently. Noted

that an independent assessment would be needed of how much the Parish Council should expect to be paid to buy out the Right of Way.

# .6 To decide on writing to EDF regarding the creation of further wetlands in the Severn levels

PT explained that EDF are on the lookout for suitable parcels of land along the River Severn to create salt marshes to offset land being used to build Hinkley Point Power Station. Given that the land at Orchard Pools should be left as an area for wildlife and not developed, there would be no harm in approaching EDF to see if they would be interested in purchasing it for their project.

# **Appendix C NPSG Report**

Neighbourhood Plan Steering Group (NPSG) Report to Parish Council 7th October 2024 - delivered by Gary Sheppard. Since last PC meeting the NPSG has had one meeting on 17th September. Matters discussed and arising since, are as follows:

#### **Flooding**

Sadly, the re-modelled 100-year flood risk data, expected at the end of February, is still not available to us. At the last PC meeting we reported that we could receive it the week beginning 2nd September, but that came and went.

Chasing them again, we were advised further errors were found, needing the model to be re-worked, so we would get the data by 4th October. Expressing the Steering Group's disappointment and how we might need to escalate things if this continues, our contact has asked us not to communicate with him directly, instead registering our request through Wessex Enquiries. He explained, the EA's objective was to obtain an accurate set of model results. However, our understanding of modelling is that you should ensure you have an accurate set of inputs and a tested and reliable model, then the results take care of themselves. It appears the EA are trying to obtain the results they want, the motive for which is unclear. We had registered our request with Wessex Enquiries twice previously, but have done it again anyway, so far only receiving the standard 20 working day response time notice.

We have now raised this with our MP and Ward Councillor at their surgery last week.

# **Neighbourhood Development Plan**

In the meantime, we've been making some good progress in moving the document forward where we can. One particular topic of interest is how we will re-define settlement boundaries in the document and what can and should be included.

#### **Evaluation of Sites**

In the requests for support from SGC for potential parking sites at New Passage and Shaft Road, we were given an alternative contact to Emma Blackham. Simon Guy has been coordinating responses from SGC colleagues in in Streetcare, the Local Plan Team, Parking services and Property Services. Unfortunately, instead of receiving advice and help, everything to have come back so far has been negative or blocking. We have emphasised we are looking to SGC to provide solutions and to plan budget for such projects. We have now raised this with our MP and Ward Councillor for them to also take forward.

We recognise that clearing land adjacent to the allotments could also alleviate visitor parking, but we need to explore fully available options.

# **Planning Applications**

The planning application for a truck stop at the entrance to Western Approach has been re-submitted. The Steering Group has re-submitted its objections.

In its role of review planning applications over the last couple of years, the Steering Group has been dismayed by the inconsistencies of planners in their considerations of flooding, Green Belt and need, seemingly differing between residential, traveller site and commercial applications. Additionally, SGC Enforcement appears unwilling to take action where sites go far beyond what they have approval for, or to take action against those involved in developments or activities, that have chosen to ignore the planning process. Again, this has been raised this with our MP and Ward Councillor

It was noted that an application to install culverts rather than bridges as an amendment to a commercial approval towards Hallen was refused. The Steering Group objected to this and is pleased to see, perhaps there is now some recognition of the increasing surface water flooding risks due to land raising and lack of rhine maintenance. Recent field flooding has been exceptional.

There have been no new planning applications of relevance to the NP although some significant decisions have been made.

# Pilning & Severn Beach Parish Council Report | Monday 7th October 2024

Key updates for Parish Council colleagues in October 2024;

- Cllr Louise Harris, Cabinet Member for the Climate Emergency at South Glos Council will be attending this years Severn Estuary Partnership meeting in Gloucester this month. I attended last years' event in Cardiff, recognising the importance of the Estuary on the ward of Pilning
- & Severn Beach.
- Cllr Sean Rhodes, Cabinet Member for Places is keen to attend an upcoming P&SB ParishCouncil meeting with a view to supporting the desire for traffic enforcement in the local area. We are mindful of the large number of lorries using local roads as shortcuts, causing issues for local people and often making the area dangerous.
- Changes to the NPPF have delayed the Local Plan for South Gloucestershire. The changes resulted in additional housing for our Local Authority which will need to be consulted on.
- Claire Young MP held a first local MP clinic in Severn Beach last week, welcoming local residents to discuss local matters and concerns, as well as raising issues of national importance. I joined the session which was well attended. A longer-term calendar of clinics will be made available shortly, but residents will be welcomed to meet with Claire in local clinics on an ongoing basis.
- Within South Gloucestershire, residents will now be aware of published plans for paid car parking in local authority car parks which will come into effect next April 2025.
- Liaison is ongoing with SGC Officers in relation to matters such as planning enforcement, with WECA regarding the desire for e-scooter trials and the need for better public transport into the ward.
