SOUTH GLOUCESTERSHIRE COUNCIL (FOOTPATH BETWEEN PUBLIC FOOTPATH ORN 19 AND PUBLIC BRIDLEWAY ORN 54 AT SEVERN BEACH) DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2024

This Order is made by South Gloucestershire District Council under section 53(2) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the South Gloucestershire District Council Definitive Map and Statement for the former Thornbury Rural District require modification in consequence of the occurrence of an event specified in section 53(3)(b), namely, the expiration, in relation to any way in the area to which the map relates, of any period such that the enjoyment of the public of the way during that period raises a presumption that the way has been dedicated as a public path, and an event specified in section 53(3)(c)(i), namely, that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path.

The authority have consulted with every local authority whose area includes the land to which the Order relates. The South Gloucestershire District Council hereby order that:

- 1. For the purposes of this Order the relevant date is 1st January 2024.
- 2. The South Gloucestershire District Council Definitive Map and Statement for the former Thornbury Rural District shall be modified as described in Part I and Part II of the Schedule hereto and shown on the map attached to the order.
- 3. This Order shall take effect on the date it is confirmed and may be cited as the South Gloucestershire Council (Footpath between public footpath ORN 19 and public bridleway ORN 54 at Severn Beach) Definitive Map and Statement Modification Order 2024.

## Modification of Definitive Map

# Description of path or way to be added

A footpath commencing on public footpath ORN 19 at **Point A** on the order plan (grid reference ST 5441 8463), within the field to the east of Severn Beach Primary School, running in an east south-easterly direction alongside a drainage ditch at the field edge for a distance of 96 metres to the edge of the field at **Point X** (grid reference ST 5450 8462) where it meets a kissing gate and then continues for a further 8 metres, crossing a culverted ditch to join with the surfaced track of the public bridleway ORN54 at **Point B** (grid reference ST 5451 8462). Shown as a bold broken line marked  $\mathbf{A} - \mathbf{X} - \mathbf{B}$  on the map contained in this order.

The width of the path is 2 metres throughout its length.

The total length is 104 metres.

The number of the footpath to be added is ORN 80.
